A. CALL TO ORDER

The October 9, 2017, Regular Board Meeting of the Terracina Community Development District was called to order at 9:00 a.m. at The Nexus at Vista Park located at 2101 Vista Parkway, West Palm Beach, Florida 33411.

B. PROOF OF PUBLICATION

Mr. Pierman presented proof of publication that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on September 21, 2017, as part of the District's Fiscal Year 2017/2018 Regular Meeting Schedule, as legally required.

C. ESTABLISH A QUORUM

Present and constituting a quorum were Chairman Guy Colella (via conference call), Vice Chairman Chesley Saunders and Supervisors Sheik Ameer and José Esquerete

Also present were: District Manager Jason Pierman of Special District Services, Inc.; and District Counsel Frank Palen of Caldwell Pacetti Edwards Schoech & Viator LLP.

D. ADDITIONS OR DELETIONS TO THE AGENDA

There were no additions or deletions to the agenda.

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. June 19, 2017, Public Hearing & Regular Board Meeting

Mr. Pierman presented the minutes of the June 19, 2017, Public Hearing & Regular Board Meeting and asked if there were any comments or questions. There being none, Mr. Ameer **moved** approval, Mr. Saunders seconded that the minutes of the June 19, 2017, Public Hearing & Regular Board Meeting be approved, as presented and the **motion** carried 4 to 0.

G. OLD BUSINESS

There were no Old Business items to come before the Board.

H. NEW BUSINESS

1. Consider Resolution No. 2017-05 – Adopting a Fiscal Year 2016/2017 Amended Budget

Mr. Pierman presented Resolution 2017-05, entitled:

RESOLUTION NO. 2017-05

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TERRACINA COMMUNITY DEVELOPMENT DISTRICT AUTHORIZING AND ADOPTING AN AMENDED FINAL FISCAL YEAR 2016/2017 BUDGET ("AMENDED BUDGET"), PURSUANT TO CHAPTER 189, FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE.

Following discussion, Mr. Colella asked about the mandatory redemption amount in the bond payments. Mr. Pierman offered to research the item and email the Board.

A **motion** was made by Mr. Ameer, seconded by Mr. Saunders and passed unanimously to adopt Resolution No. 2017-05, as presented.

2. Consider Approval of Auditor Renewal

Mr. Pierman explained that the Board had previously selected Berger Toombs Elam Gaines & Frank, through the audit selection process, and awarded them a three-year contract with an option to renew for an additional year.

A **motion** was made by Ms. Ameer, seconded by Mr. Colella, and unanimously passed to renew Berger Toombs Elam Gaines & Frank's agreement for an additional year.

3. Discussion Regarding District Lakes and Fountains

Mr. Ameer noted that the new fountains are not as high as the others in the community and requested that staff look into the discrepancy. He also requested that debris cleanup be included in the lake maintenance contract. Mr. Pierman agreed to inquire with Palm Beach Aquatics on the cost of that addition, and noted that Palm Beach Aquatics had set the fountain timers. Discussion also arose regarding the lake levels, and Mr. Ameer offered to take pictures of the water levels for reference.
